Spring 2023 Memo from your LCCPOA Officers/Directors....

PLEASE PLEASE be aware that ALL roadways in LCC are PUBLIC ROADWAYS and are subject to ALL applicable SC Laws and Georgetown County Ordinances. In particular, be aware that **golf carts are considered to be "motorized vehicles"** requiring operators to be licensed drivers and observe speed limits. **Further down this newsletter you will find a detailed recap of the laws and rules about golf cart operation.**

GOOD NEWS at last about maintenance and landscaping of the entryway at US17 and Country Club Drive. We have reached an understanding providing for the actual work being done by Founders. LCCPOA and The Lakes at Litchfield will reimburse Founders for part of the cost. Important Notice from Golf Course Management

Dear POA Members,

As the weather has been improving, we notice the use of our property is increasing. We understand that it is a great area for recreation, but please remember that it is private property. We ask you to refrain from walking, biking, jogging or ball hawking between the hours of 7:00am and 7pm so that our maintenance crew can prepare the course and so our guests can enjoy their round of golf. You do not want to be struck by a golf ball and no one golfing wants to hit someone. So, for your safety and the enjoyment of our guests please enjoy your walk outside of the listed hours. **At no time should you be playing golf without checking in with the Pro Shop.**



We want to be good neighbors and we understand that it is safer to walk on the course than on the road. However, if we see you on the course during play, we will ask you to leave.

Fishing has also increasingly become a problem. No one has permission to fish in any of the ponds on LCC property. If you see someone fishing in our ponds, please call the golf shop at 843-237-3411 x 1 and we will ask them to leave.

Lastly, personal golf carts. I made a mention of this at the annual meeting, but I feel it needs to be mentioned again. We do not allow personal carts on our property. You may not ride the cart paths or any other part of the course. You may be held liable for any damage caused to the golf course.

Have you heard of St. Christopher's Children?

Have you heard of St. Christopher's Children? We are a nonprofit organization established in 2007, providing needed clothing and critical orthodontic care for children in Georgetown County, SC, when no one else is there to help with these services. Each year we help over 300 children with basic clothing and have a wait list for orthodontic care. The children are the HEART of our mission. We provide new clothing personally selected by one of our volunteer shoppers. Orthodontic care is prioritized based on the severity of the case. We work closely with local school nurses who see firsthand the needs of these children.

Last year, St Christophers Children provided 25 children with orthodontic care, 241 children with new clothing, and 175 new coats were distributed. Salty Dogs Rescue Update



If you've been following Salty Dogs Rescue, then you may know by now, our goal is to rescue senior dogs approximately age 7 and up. Older dogs are most often overlooked in shelters for puppies or younger dogs. However, just like humans, the life expectancy of dogs has a wide range. The rule of thumb use to be that smaller dogs lived longer, yet there are stories of 16-year-old labs, pit bulls and shepherds, and mixed breeds typically live longer than purebreds. Also, just like humans, what matters most is the care and health of the animal. Although 7 may seem old to some, for many it may be only mid-life or a third of their life span.

On March 27th, Salty Dogs celebrated its first official year. Between May of 2022 when we rescued our first dog and the end of 2022, we rescued 34 dogs and found homes for 31 within the same year. By January of 2023, our last few dogs were adopted. 2023 is turning out to be a significantly more successful year, where we rescued 32 dogs just in the first quarter and another 10 in April. To date, we are averaging 9 adoptions a month. The average of our dogs being in foster is 36 days. However, some dogs, we only have for a few short days before they find a home. This is due to many factors, but usually it's their current medical needs. We have had animals come in with eye infections, kidney issues, tumors and unaltered. It's hard to believe that for many of these dogs, who have had homes prior, at their advanced age they are still not spayed or neutered. We will not release a dog out for adoption without being spayed/neutered. When agreeing to take a dog, our first goal is to ensure we have a foster, our second is to get them to the vet to determine their healthcare needs. We are happy to say, that only 2 of the dogs we have rescued, have not been able to successfully been rehomed due to medical. However, we know that we were able to ensure their last few weeks were safe, warm and loving.

Since Salty Dogs is a foster only rescue, a large part of our success rests with the foster component. The more fosters we have, the more dogs we are able to rescue. If you have ever considered fostering, or even if you haven't, here are a few things to ponder if you're looking to make a difference in an animal's life.



The Benefits of Fostering

Foster programs offer a second chance at life and transform dogs from [shelter animals](#) to pets ready to find their forever families. Here are four tremendous benefits you need to know.

1. It's a learning experience

One of the most significant benefits of fostering dogs is learning from the experience. You and your family will have the opportunity to interact with different [dog breeds](#). If you have children or grandchildren, they'll [learn about raising and training](#) pets.

The foster dog will also learn from the experience. When fostered successfully, they'll have a chance to socialize and begin to trust people. If you have other animals in the home, it also allows them to interact together.

2. It releases you from long-term commitments

When you adopt a dog, [you make a lifelong commitment](#) to care for the animal. In many cases, this could mean a 10–15-year responsibility. You don't have such a lengthy commitment to the animal with fostering. At most, [foster pets](#) are usually in your care for a matter of months rather than years. Fostering allows you to explore other interests. You may decide after a year that you're ready to adopt, or you may prefer to stop entirely. Either way, you're still in control of your time and commitments. Additionally, even if you have a short-term commitment that comes up during your fostering, we will make other arrangements to find a temporary foster for your foster dog, if they haven't been adopted.

3. It provides a sense of purpose

Fostering can provide a sense of purpose and fill a hole in your life that you may not even know existed. Research shows that animal companionship [can reduce symptoms of depression](#), calm the mind and promote healthy living. Most dogs require walking if you don't have a fenced in yard. Even if you do, they may enjoy the exercise. This also allows you to get out and enjoy the sunshine and get those steps in. In essence, you are [saving the dog's life](#), but they might also be saving yours.



The Benefits of Fostering (cont.)

4. It's practically free

Unlike personal pets, Salty Dogs provides you with all the essentials, a bed, crate (if necessary), collar, harness, leash and all medical needs. We do ask that the fosters contribute the food, however, if it's not feasible, we will also provide that. This means you can enjoy the benefits of pet companionship at a fraction of the usual price of dog ownership.

Take a chance

Fostering a [dog can change your life](#) and theirs if you are willing to take a chance. Even if it's not for you, please pass the word. Just looking at our numbers from 2022 through these first few months of 2023, show what we can do for these animals with an increase in foster homes. Reminder to be Neighborly

Please be cognizant that your neighbors noise tolerance may not be the same as your own. They may have health or family issues that you are not aware of and loud noises are extremely bothersome.

So please try to be courteous that you aren't operating loud mowers & blowers early in the morning or evening, and that dogs aren't left outside to bark continuously during the day & night. These are just two examples.

Many of the LCCPOA board members have gotten calls and emails over the past month regarding numerous complaints. We ask that you please make an effort to be considerate of your neighbor. If you have a concern with your neighbor's actions, please speak with them directly as they may not even be aware of the issue at hand. I have personally found that chatting directly with your neighbors is a much better way to avoid conflict then getting a third party involved.

We need volunteer Neighborhood Watch drivers

Our Litchfield Country Club POA (LCC POA) operates a neighborhood watch program staffed by volunteer member drivers. Watch Drivers cruise our streets daily looking for signs of trouble, illegal activity, speeding, improper parking, and neighbors in need of assistance. Drivers then log the results of their watch.

Our drivers typically perform their one-week tours on a quarterly basis. Each tour of our Litchfield Country Club roads takes a little over an hour. It is easy and a good way to meet neighbors, support safety, and become more familiar with your neighborhood. The Georgetown County Sheriff's Department has praised our neighborhood watch program as one of the best around.

As an added incentive, new Drivers will be offered a Free 9 hole golf round at Litchfield Country Club! Please contact Director Ken Fetzner for more information. Ken will 'show you the ropes' when you volunteer.

What Can We Do About Speeding in LCC?

Speeding remains the number one concern expressed by LCC POA members. At our recent POA annual meeting, a lieutenant from the Georgetown County Sheriff's Office (GCSO), indicated that if members observe **excessive** speeding, they can report the license number of the offending vehicle better yet, they can send a photo of the license plate to GCSO and an officer will contact the owner of that vehicle warning them about speeding in Litchfield Country Club. For commercial vehicles the same applies or we can report the company name and the time of the infraction.

Common sense should be applied so that the GCSO is not overburdened by following up on reported speeding that is estimated to be less than, say 35 mph. Please use your best judgment. The higher speed drivers pose the most danger to walkers, children and pets.

To report an excessive speeding incident contact POA Safety Director, **Ken Fetzner**, (ken@litchfieldpoa.com). GCSO would prefer that these notifications come from a single source. To ensure reporting accuracy, it would be better to email Ken rather than calling him."

Certain wildlife can become problems. Here are a few tips that may minimize visits from unwelcome animals. 🐸🐊🐉🐍🐻

- Remove any **pet food** from outside your house after the pet has been fed.
- Secure garbage containers and eliminate garbage odors.
- Clean up birdseed scattered on the ground beneath feeders.
- Securely close all entryways to access beneath trailers or houses (including garage doors).
- Do not approach or handle wildlife that appears friendly.
- Don't leave small children outside unattended.
- Don't allow pets to run free. 🐕🐕🐕

Penalties for golf cart violations in Georgetown Cty:

Penalties for violation of state laws governing the operation of low speed vehicles – including golf carts – on roadways have recently changed! Such violations are considered a misdemeanor under state law, and **conviction is punishable by a fine of up to \$100 or imprisonment for up to 30 days.**

The following requirements are included in the laws for operation of golf carts in the state and in Georgetown County.

- A person operating a permitted golf cart must be at least 16 years of age and hold a valid driver's license.
- A golf cart operating on roadways must have liability insurance.
- A golf cart has to be permitted by the State of South Carolina. An individual or business owner of a vehicle commonly known as a golf cart may obtain a permit decal and registration from the Dept. of Motor Vehicles upon presenting proof of ownership and liability insurance for the golf cart and upon payment of a \$5 fee.
- A golf cart can only be operated during day light hours, including carts with headlights and turn signals.
- The operator of a permitted golf cart being operated on a highway or street must have in their possession: 1) the registration certificate; 2) proof of liability insurance for the golf cart, and 3) their valid driver's license.
- A permitted golf cart may be operated within four miles of the address on the registration certificate and only on a secondary highway or street for which the posted speed limit is 35 miles an hour or less. Highway 17 Business in Murrells Inlet is not considered a secondary highway.
- A golf cart cannot be operated on a public bike path or public beaches in Georgetown County.
