## DISCOUNTED TRASH REMOVAL

**The LCC POA has an agreement with Bill Floyd Services, Inc. (BFS) to provide deeply DISCOUNTED trash removal services to POA Members.**

More than 230 of your LCC neighbors currently enjoy the deep discounts provided by the trash collection program. Participation is ANNUAL and is CALENDAR YEAR. Annual enrollment period is in the fall of each year for the succeeding year.

### PROGRAM OUTLINE:

- Pickups once weekly on Mondays including holidays except Christmas and New Years
- One new, free 95 gallon 2-wheeled bin provided.
- Extra bags/ boxes, etc. left out by trash bins will be picked up (within reason).
- Areas around containers will be free of loose garbage after each pick-up.
- BFS has agreed to require their trucks to observe our neighborhood speed limit.
- No yard debris or Christmas trees.

### ELIGIBILITY:

- **YOU MUST BE AN LCC RESIDENT AND A CURRENT LCC POA MEMBER TO PARTICIPATE.**
- Payment for trash removal service is **ONCE** annually **to the POA**. Payment may be check or cash. Current annual cost is \$176.

## **DISCOUNTED RECYCLING SERVICE**

**Tired of driving to the recycling center and having to separate recyclable items? Your LCC POA offers deeply discounted, bi-weekly, commingled curbside recycling pickups on alternate Mondays.**

**Participation is annual by calendar year. Enrollment periods are in the fall of each year for the succeeding year. Current cost is \$174 annually.**

### **DETAILS:**

BFS is our provider. Subscribers will be provided an BFS 95-gallon, covered recycling roll container.

- Containers are emptied every other week on Mondays.
- Routes disrupted by holiday Mondays will be made up the following day.
- All containers must be rolled to the curb by 6am on Mondays.
- Plastic, metal, glass, paper and cardboard all go into the same container.
- Household garbage, paint, paint cans, yard waste, tires and hot ashes are not acceptable.
- Recyclable material, including reasonable bagged material next to bins, will be removed at each pickup.
- BFS will comply with all posted LCC speed limits.
- If a subscribing LCC POA member sells a residence during a prepaid period year, a new resident may assume the remainder of the prepaid service year pursuant to an agreement between seller and buyer.

# Deed Covenant

1. This lot shall be restricted to residential purposes only and shall not be divided or reduced in size by the Grantee, heirs, successors or assigns without the prior written consent of the Grantor, its successors or assigns. No additional street, roadways or driveways shall be opened through any lot to serve adjoining property.
2. No structures shall be erected on this lot other than a detached single family dwelling not to exceed two stories in height with attached or detached garage and/ or servant's quarters of similar design and appearance.
3. No concrete blocks, either in building or walls except decorative screen blocks, shall be used above finished ground elevations unless same is covered with brick veneer, stone or stucco.
4. No fence, wall hedge or mass planting shall be permitted to extend beyond the minimum building setback from the rear line established herein or within forty (40) feet of any golf course property line except upon written approval of the Grantor herein.
5. No noxious or offensive activities shall be carried on or permitted upon this lot nor shall anything be done thereon which may become any annoyance or nuisance to the neighborhood or golf course. No hogs, goats, poultry, cows, horses or other animals that shall constitute a nuisance or cause unsanitary conditions or undesirable situation to any property shall be boarded, maintained or kept on this lot.
6. No temporary structures including house trailers, tents, shacks, barns, shell type or prefabricated home, or garage apartment shall be erected upon any lot.
7. No individual sewage disposal system or individual water supply system shall be permitted on this lot unless said system is designed, located and constructed in accordance with the requirements of the State Board of Health and the Georgetown County Health Department.
8. No residence constructed on this lot, including porches or projections shall be erected less than thirty (30) feet from the front lot line, nor forty (40) feet from the rear line. No residence shall be located less than thirty (30) feet from the side street line nor less than fifteen (15) feet from the side lot line, except in the event two lots are purchased for the purpose of erecting thereon one single family dwelling the dividing line between said lots shall not be considered as a side line.
9. The residence to be erected on said lot shall contain not less than 1200 square feet of heated living space. Any residence which exceeds one story shall not have less than 900 square feet on the ground floor and shall be a permanent design, shall have a fire resistant roof and the exterior thereof shall be finished in and decorated in an attractive manner. No building or fence shall be erected upon the lot until the location and exterior plans thereof shall have been submitted to and approved by the Grantor herein in advance of construction, and its consent will be given only if the location, construction and appearance of the building and/ or fence meets with its approval.
10. No firearms of any variety shall be discharged upon said lot.
11. No business activity including a rooming house, boarding house, a gift or antique shop or the like or any trade of any kind whatsoever shall be carried on upon this lot.
12. An easement is reserved to the Grantor, its successors or assigns in, upon and across ten (10) feet along each sideline and across the rear line for utility installation, utility right- of-way and maintenance thereof. The right is also reserved by the Grantor to prepare sloping banks, cut or fill, on a three-to-one slope on all streets and roads.

13. \*Prior to agreeing to convey or alienate this lot the Grantee herein agrees to give the Grantor, its successors or assigns, a twenty (20) day written option to repurchase this lot at a price equal to the bona fide offer which he shall be receiving from the prospective purchaser.

The written option must include the name and address of the prospective purchaser together with his written offer to the Grantee herein. In the event the Grantee herein conveys this lot without compliance with this restriction, Litchfield Golf Co., Inc. shall have the right at any time within three (3) months after receiving actual notice of said sale to tender an amount equal to the price received by the Grantee herein and demand from the then title holder the conveyance of this lot to Litchfield Golf Co., Inc. its successors and assigns.

14. Adequate off street parking shall be provided by the Grantee herein for the parking of automobiles or other vehicles owned by said Grantee and said Grantee agrees not to park his automobile or other vehicles on the street of the subdivision.

15. The Grantee herein agrees to extend to any and all golfers lawfully using the golf course the courtesy of allowing such golfer to retrieve any and all errant golf balls which have taken refuge on said lot provided such golf ball may be retrieved without damaging the property of the Grantee herein.

16. No boats, canoes or rafts shall be used upon any pond or lake unless the Grantor first gives its written permission. The Grantee herein or his guests shall have no right to use the lake within the golf course property or other facilities of the Gmter unless said Grantee is a member in good standing of the Litchfield Golf Club.

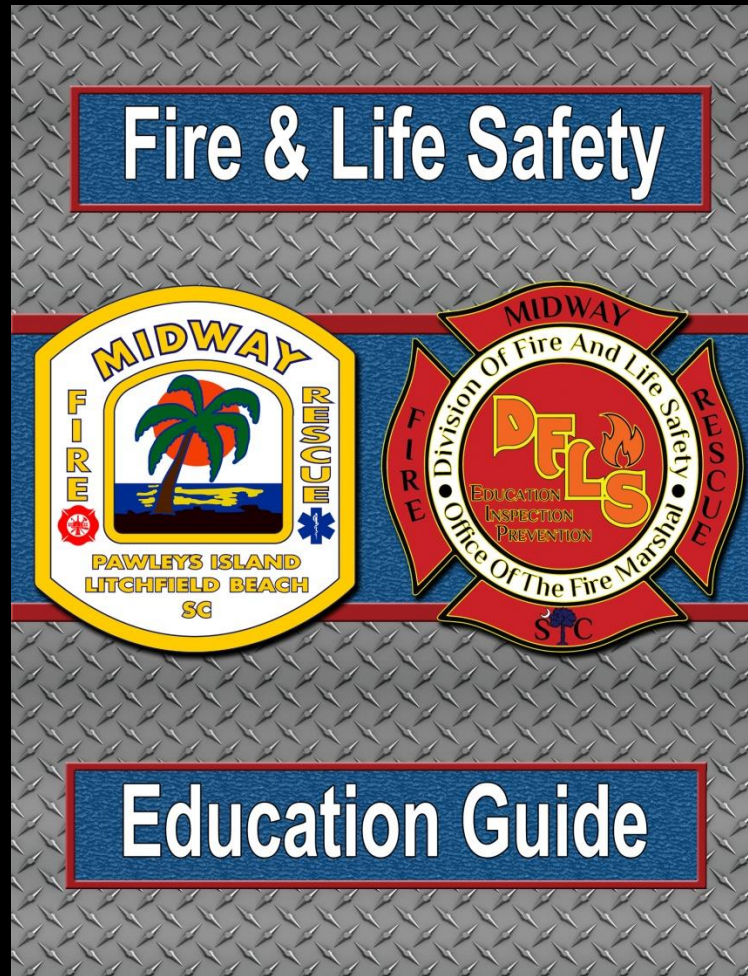
17. No person whomsoever shall traverse any of the fairways or greens of the golf course on any vehicle, bicycle or any other vehicle other than golf carts authorized for use on said golf course

18. It is understood and agreed that the foregoing conditions, covenants and restrictions shall be appurtenant to the run with the said premises; that, in the event of violation of any of said conditions, covenants and restrictions, the said Grantor, its succe•ors or assigns, shall have the right of abatement and the right to enforce compliance by injunction or any other appropriate legal action

19. It is understood and agreed that these covenants, conditions and restrictions are made solely for the benefit of the Grantee herein and may be changed at any time by mutual consent in writing of the parties hereto, their heirs, successors or assigns.

•As of 3/2003 the above mentioned Litchfield Golf Company, Inc. named the Litchfield Country Club Property Owners Association, Inc. (LCCPOA) as, with the exception of item number thirteen ( 13, its all the above restrictions. On March 20, 2003 number 13 of the above restrictions was assigned by the Litchfield Golf Company to the Litchfield Company of South Carolina Limited Partnership, a South Carolina Limited Pannership ("The Litchfield Company")

To our Citizens and Community Partners,

Midway Fire Rescue is excited to implement a Smoke Alarm Installation and Fire and Life Safety Education Program into our community. This is a Community Risk Reduction partnership between Midway Fire Rescue and the members of our community, with program equipment funded through a grant award from the Department of Homeland Security, Fire Prevention and Safety Grant Program.

The primary goal of this program is to eliminate injuries and deaths as a result of fires across our community. We will reach this goal by providing smoke alarms to homes that currently lack them, and by providing homeowners with guidance on how to replace their outdated smoke alarms (those smoke alarms over 10-years old). We will also provide each home we visit with a Fire and Life Safety Education Guide, which we ask you to share with your entire family.


We are proud to be able to provide smoke alarms to you and your family. We know that maintaining properly operating smoke alarms in your home is the number one defense in protecting you and your family in the event of a fire. We also stress to you the importance of reviewing the information contained in the attached Home Safety Guide with your entire family, so together we can ***Make Everyday a Fire Safe Day.***

## Updating the Smoke Alarms in Your Home


Midway Fire Rescue

Community Safety Guideline

**To ensure the safety of your family in the event of a fire, Midway Fire Rescue will install properly operating smoke alarms in your home, powered by 10-year lithium batteries**

**Midway Fire Rescue will take the following steps to protect your family:**

- Members will determine the type, age, and power source of your current smoke alarms and if they are operating properly
- If your smoke alarms are battery operated only, we will replace them with 10-year lithium battery smoke alarms
- If your smoke alarms are powered by your electrical system with a 9-volt battery back-up, and are over 10 years old, they should be replaced. Midway Fire Personnel cannot change these aged smoke alarms, as we cannot alter the electrical system in your home for liability purposes
- In an effort to ensure your family is protected, our members will install TEMPORARY 10-year lithium battery smoke alarms near your sleeping area. These will serve as a back-up to your end-of-life smoke alarms, until you are able to replace them
- We request you replace these end-of-life smoke alarms which are wired to your electrical system with a 9-volt battery back-up. We recommend smoke alarms which are wired to your electrical system with a 10-year lithium battery back-up. This installation can be done by a family member, friend, handyman, or electrician. Please follow all installation instructions



### Five Quick Tips

1. Smoke alarms should be installed on every level of your home, as well as inside of all sleeping areas.
2. You should test your smoke alarm each month.
3. You should lightly dust or vacuum your smoke alarm after each test.
4. Smoke alarm should be completely replaced every 10 years.
5. Your family should plan and practice a home escape plan during your monthly smoke alarm testing routine.

### Options to replace your end-of-life, wired-in Smoke Alarms

- Please ensure the new smoke alarms you purchase are designed to be wired-in to your electrical service, and are equipped with a 10-year-life lithium battery back-up
- If you have the capability to replace your smoke alarms, we suggest you follow all the instructions on the new smoke alarms, and secure the power supply before you complete the work
- If you do not have the capacity to install the new smoke alarms, we suggest checking with family members or friends who are able to safely complete the installations.
- Other options include a local handyman, electrician, or heating and air-conditioning serve person.
- These replacements are considered maintenance work and do not require any permitting from the county

### Where to Install Your Smoke Alarms

- You should install a smoke alarm in each bedroom and sleeping area inside of your home
- There should be a smoke alarm in the hallway outside of the bedrooms
- You should not install smoke alarms near fireplaces, wood stoves, or in the kitchen; they tend to false alarm more frequently in those areas.
- Install smoke alarms at least three feet from any air return or air vent.
- If you have to install your smoke alarm on a wall, it should be placed at least 12 inches below the ceiling.

## Smoke Alarms

### What Are the Different Types of Smoke Alarms ?

- **Ionization Alarms** – These types of smoke alarms sound in a quicker time-frame during a fast and flaming fire.
- **Photo-Electric Alarms** – These types of smoke alarms sound in a quicker time-frame during a smoky and smoldering fire.

### What Are the Different Types of Power Sources?

- **House Current Power** – All homes built beginning in the mid-1980's required the smoke alarms to be wired into the home, and also have a battery back-up. If a 9-volt back-up battery is present, it should be replaced at least yearly. If the back-up battery is a more modern lithium battery, it cannot be replaced, and the Smoke Alarm should be replaced every 10 years.
- **9 Volt Battery Power** – These smoke alarm batteries shall be replaced at least once a year. If the smoke alarm is over 10 years old, it is recommended to replace with a lithium battery powered smoke alarm.
- **Lithium Battery Power** – Lithium batteries do not have to be replaced. It is recommended to replace the entire smoke alarm every 10 years. **THIS IS THE SMOKE ALARM OF CHOICE**



#### Five Quick Tips

1. Smoke alarms should be installed on every level of your home, as well as inside of all sleeping areas.
2. You should test your smoke alarm each month.
3. You should lightly dust or vacuum your smoke alarm after each test.
4. Smoke alarm should be completely replaced every 10 years.
5. Your family should plan and practice a home escape plan during your monthly smoke alarm testing routine.


#### How to Maintain Your Smoke Alarm

- You should test your smoke alarm once a month with the test button and every six months with smoke from a blown-out candle.
- You should remove the cover and gently vacuum or dust your smoke alarm at least once a month.
- Standard 9-volt battery powered smoke alarms should have the battery replaced yearly; do this when you change your clock in the fall.
- Lithium battery powered smoke alarms do not need new batteries each year; instead, replace the entire smoke alarm every 10 years.
- Never paint over any portion of your smoke alarm.
- If your smoke alarm activates due to smoke or fire in your home, the smoke alarm should be replaced.

#### Where to Install Your Smoke Alarm

- There should be a smoke alarm on every level of your home.
- You should install a smoke alarm in each bedroom and sleeping area.
- You should not install smoke alarms near fireplaces, wood stoves, or in the kitchen; they tend to false alarm more frequently in those areas.
- Install smoke alarms at least three feet away from any air return or air vent.
- If you have to install your smoke alarm on a wall, it should be placed at least 12 inches below the ceiling.

**We suggest you replace all your 10-year-old smoke alarms with Lithium Battery Powered smoke alarms**

Community Safety Guideline

### When to Call 9-1-1

Many people are hesitant to call 9-1-1 because they are unsure if their situation is an emergency, or they do not want to be a bother. **Always call 9-1-1 in the event of: Fires, Medical Emergencies, and Criminal Activity.**

### When Not to Call 9-1-1

If a true emergency does not exist, or you are seeking non-emergency information, please locate the non-emergency number for the local Fire Department, Police Department or Sheriff's Office to call for information.



#### Five Quick Tips

1. Make sure emergency responders can clearly and easily see your house number.
2. Turn your porch light on and have someone meet the emergency responders at the street or driveway.
3. Advise the emergency responders of special issues prior to entry, such as dogs, hazards, and best access.
4. Do not block access to fire hydrants with fences, shrubs, cars or obstructions.
5. Answer all questions of the 9-1-1 Center call taker.

#### Calling 9-1-1 from Home

Many areas have Enhanced 9-1-1 (E 9-1-1) and the call taker is automatically provided the location of the caller. We stress to always confirm the location of the emergency with the call taker before hanging up.

Cell phones do not have the E 9-1-1 capability, so the call taker will not know where you are calling from unless you tell them your exact location.

#### When speaking to the call taker at the 9-1-1 Center:

- Speak calmly and clearly.
- Provide the exact address or location of the emergency.
- Provide the phone number you are calling from. Regardless of E 9-1-1.
- Describe the emergency.
- Give your name and information about who is involved.
- Answer all other questions as quickly and accurately as possible.
- Receive instructions given to you by the call taker.
- Stay on the phone until the call taker advises otherwise.

**If you are ever in doubt of the situation, DO NOT HESITATE to call 9-1-1**

## Cooking Safety

### Helpful Hints to Prevent Fires and Injuries in the Kitchen

- Fires originating in the kitchen are the leading cause of accidental fires in the home. The leading cause of kitchen fires is cooking with grease or oil. **NEVER LEAVE THE KITCHEN WHEN COOKING WITH OIL OR GREASE**
- In the event of a stove-top fire, never move a burning pan, and never extinguish with water. Ensure you have a fire extinguisher in the kitchen, and always have a pan-top or cookie sheet close by when cooking with grease or oil
- Proper housekeeping can reduce many fires in the kitchen, ensure there is no excess grease or food scraps under burners, or in the bottom of the stove. Never leave pot holders, towels, or paper and plastic items on the stove top.
- Always utilize the back burners of a stove, particularly if you have children in the home. Keep all pan handles facing the rear of the stove, and never leave them hanging over the stove front.
- If you or a family member receives a burn injury, immediately cool the area with cold tap water. If the burn forms a blister larger than a quarter, you should seek medical attention.
- If you leave the kitchen while the stove is on, always carry a cooking spoon or pot holder as a reminder, setting timers is also a good practice when leaving the room. **NEVER LEAVE WHEN COOKING WITH OIL OR GREASE.**



#### Charcoal and LP Gas Grilling Safety

- When cooking on your LP Gas or charcoal grill, it should be placed in the yard or the outer portion of your deck. Never put it against the home or any combustible surface.
- When grilling has been completed, make sure your LP Gas is shut off at the bottle, and if using charcoal, the briquettes have been completely extinguished with water.
- Only use commercial lighter fluid to start your charcoal. Never use gasoline, kerosene, or any other type of flammable liquid.
- Never operate any type of grill inside your home, camper, garage, vehicle or tent.
- Store your spare LP Gas cylinder in a cool, shaded area; never keep it next to the grill. The cylinder should always be stored and transported upright.
- As a "Rule of Thumb", it is illegal to use an LP gas, or charcoal grill on an apartment or condominium balcony.



#### Keeping Children Safe in the Kitchen

- Children should always be supervised whenever they are in the kitchen.
- Keep place mats and tablecloths off of the table when there are toddlers in the home, as they will reach up and use them for leverage to stand up.
- The temperatures reached on oven doors are hot enough to burn a child's hands; never operate the oven when toddlers are in the kitchen.
- Do not allow children to play with pots and pans, as they will see them hanging over the edge of the stove and grab them when they contain a hot liquid.

**NEVER LEAVE THE KITCHEN WHEN COOKING WITH OIL OR GREASE**

#### Five Quick Tips

- Always stay in the kitchen when you are frying, broiling or grilling food.
- Keep a pan top or a cookie sheet nearby whenever cooking. Cover a burning pan with either of these in the event of a fire.
- Never pick up and move a burning pan from the top of the stove.
- Install a fire extinguisher near the exit door from your kitchen. If a stove top fire is small enough, use the fire extinguisher to put out the fire.
- Keep the cords to all electrical appliances wrapped so they do not hang over the counter, tempting a child to pull on them.

## Fire Extinguishers

### What Are the Different Types of Fire Extinguishers?

There are three different types of fire extinguishing agents for home use. Portable fire extinguishers are labeled according to the type of fire they are used for: pressurized water for "Type A" fires; carbon dioxide for "Type B" fires; and dry chemical for "Type C" fires. There is also a multipurpose dry chemical for "Type A, B and C fires". Fires involving ordinary combustible products, flammable liquids and electrical fires can react different to the type of extinguisher being used. The three classes of fires and examples are:



Type "A" fire extinguishers are used for ordinary combustible products such as paper, wood, rubber and many plastics.



Type "B" fire extinguishers are used for flammable liquid fires such as grease, oil, gasoline and solvents.



Type "C" fire extinguishers are used for electrical fires in wiring, fuse boxes, electrical equipment, and other devices powered by electrical current.



#### Five Quick Tips

- If there is a fire call 9-1-1.
- Know how to use a fire extinguisher and understand the risks of fighting a fire.
- If the fire is too large, do not attempt the use of a fire extinguisher.
- If it is too hot, or too much smoke in the area, get out.
- Always stay between what's on fire and your exit from the room or building.

#### Proper Use of Fire Extinguishers

Get proper training on the use, care, and maintenance of your fire extinguisher.

Remember: fire extinguishers are not meant to fight a large or spreading fire.

Know the acronym **P.A.S.S.** when operating a fire extinguisher.

- Pull the ring pin breaking tag
- Aim the nozzle at the base of the fire
- Squeeze the handle
- Sweep the nozzle from side to side at the base of the fire

**Make sure your fire extinguisher is the right type and size for the fire you are attempting to extinguishing**

#### Is Your Fire Extinguisher...

- Accessible and not blocked by furniture and other objects.
- Still pressurized with the gauge in the green zone.
- Nozzle clear and unobstructed.
- Pull pin and tamper seal still in place.
- Free of rust and signs of wear.
- Less than 10 years old.

When using a fire extinguisher during a fire, always stay between the fire and your exit out of the room or building
